### **TOWN OF THE PAS**

#### **BY-LAW NO. 4536**

BEING A BY-LAW OF THE TOWN OF THE PAS IN THE PROVINCE OF MANITOBA TO PROVIDE FOR THE CREATION OF A RESERVE FUND FOR DESTINATION MARKETING AND TO REPEAL BY-LAW NO. 4454.

WHEREAS Section 168(1) of the Municipal Act provides that a council may by by-law establish reserve funds for any general or specific purpose;

WHEREAS the Town of The Pas has enacted a tax on accommodations of short duration within the Town of The Pas intended to generate revenue for the specific purpose of Destination Marketing;

**AND WHEREAS** it is deemed necessary and desirable to establish a reserve fund for expenditures in regards to Destination Marketing.

NOW THERFORE THE COUNCIL OF THE TOWN OF THE PAS IN COUNCIL DULY ASSEMBLED ENACTS AS FOLLOWS:

#### **Short Title:**

 This By-law may be referred to as the Destination Marketing Reserve Fund By-Law.

### **Definitions:**

- 2. In this By-Law:
  - "Destination Marketing Reserve Fund" means the Town of The Pas reserve fund established for the purpose of providing financial means for promoting economic development by increasing visits to The Pas which generate overnight stays, visits to restaurants and shopping venues, for example: hockey tournaments, home coming celebrations, business conferences and events that create economic development.

"reserve fund" means a reserve fund for a specific purpose within the meaning of section 168 of the Municipal Act.

#### **Establishment of Reserve Fund:**

- 3.1 A reserve fund for the specific purpose of Destination Marketing be established.
- 3.2 The reserve fund established by subsection (1) may be referred to as the Destination Marketing Reserve Fund.

### **BY-LAW NO. 4536**

## A Portion of the Accommodation Tax to be Deposited into the Fund:

- 4.1 A portion, being 25%, of the tax collected under the Town of The Pas Accommodation Tax By-Law No. 4535 be appropriated to the Destination Marketing Reserve Fund established by section 3 of this by-law.
- 4.2 Notwithstanding paragraph 4(1) of this by-law, any amount to be refunded under section 6 Refunds of the Town of The Pas Accommodation Tax By-Law No. 4535 may be withdrawn from the Destination Marketing Reserve Fund.

## **Expenditures from the Fund:**

- 5.1 Expenditures from the Destination Marketing Reserve Fund established by section 3 of this by-law may only be for the specific purposes of Destination Marketing.
- 5.2 The Town of The Pas shall keep a separate account in its books designating the purpose for which the fund was created and showing at all times the status of the reserve fund.

# Repeal:

6. By-Law No. 4454 be hereby repealed.

## **Coming into Force:**

This by-law shall take force and be in effect as the date it is passed. 7.
