

TOWN OF THE PAS

BY-LAW NO. 4425

BEING A BY-LAW OF THE TOWN OF THE PAS TO AMEND SCHEDULE "A" TO SEWER AND WATER RATES BY-LAW NO. 4319 AS AMENDED BY BY-LAW NO. 4414.

---

**WHEREAS** By-Law No. 4319 established sewer and water rates within the limits of The Town of The Pas;

**AND WHEREAS** By-Law No. 4319 was amended by By-Law No. 4414 to enact Public Utilities Board Order No. 163/08 dated December 15, 2008 which approved a 15% interim rate increase in water and sewer rates for the Town of The Pas, effective on all consumption on and after January 1, 2009;

**AND WHEREAS** by Order No. 87/10 dated August 17, 2010, the Public Utilities Board (Board) approved an interim *ex parte* water and sewer (utility) rate increase for the Town of The Pas, effective on all consumption effective for the next quarterly billing, scheduled to go out in October 2010. The Board will also approve an additional 5% increase to be effective January 1, 2012, therefore it is deemed necessary and expedient to amend Schedule "A" to By-Law No. 4319 as amended by By-Law No. 4414;

**NOW THEREFORE THE COUNCIL OF THE TOWN OF THE PAS IN COUNCIL ASSEMBLED ENACTS AS FOLLOWS:**

1. **THAT** Schedule "A" attached to By-Law No. 4319 as amended by By-Law No. 4414 be amended to set forth sewer and water rates under Public Utilities Board Order No. 87/10 and being attached as Schedule "A" to this by-Law.
2. **THAT** the new rates shall take effect for the next quarterly billing, scheduled to go out in October 2010. The Board will also approve an additional 5% increase to be effective January 1, 2012

2. Minimum Quarterly Charges

Notwithstanding the commodity rates set forth in Paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include water allowance indicated;

(b) Water Only Customers

Minimum charge will be the same for each meter size as shown above, but, the Sewer Commodity Charge will be excluded.

(c) Sewer Only Customers

Minimum charge will be the same as shown above, but, the Water Commodity Charge will be excluded.

3. Bulk Water Rate

All water sold in bulk by the Town of The Pas shall be charged for at the rate of \$10.00 per thousand gallons.
